
With support from our partners, NEEF was also able to award approximately \$781,000 in grants in 2021 towards conservation and education efforts across the country.

Health

During a time of increased demand for environmental health information, NEEF developed new models for delivering important health resources to our core audiences of families, school nurses, and health care professionals, improving overall engagement.

Healthcare Professional Engagement and Education

837 school nurses completed NEEF's Creating Asthma-Friendly Environments online e-learning course module, potentially impacting 627,750 students.*

Power of Parks for Health

In partnership with National Park Service, NEEF hosted its first Power of Parks for Health roundtable series to facilitate open dialogues around equity, health, healing, and wellness in the outdoors for individuals representing communities that have been historically marginalized from green spaces.

Children's Environmental Health Series

More than 1,100 healthcare professionals participated in NEEF's virtual Children's Environmental Health Series. Featured speakers included former US Surgeon General Dr. Regina Benjamin and two-time NBA champion with the Los Angeles Lakers, Josh Powell, who addressed advancing health equity for all and the importance of nature exposure for health and wellness.

Conservation

Despite the ongoing COVID-19 pandemic, National Public Lands Day (NPLD) 2021 was successful as a hybrid event with both in-person and virtual activities. The nation's largest single-day celebration of public lands hosted more than 500 events and engaged nearly 50,000 volunteers in hands-on conservation. NEEF estimates that volunteers logged more than 180,000 hours and provided volunteer service valued at \$5.3 million.

Additionally, NEEF provided \$571,000 in grants to organizations supporting NPLD, improving regional biodiversity, and helping America's public lands recover from the impacts of the COVID-19 pandemic.

Engagement Campaigns

NEEF worked with 3M and Republic National Distributing Company (RNDC) on employee engagement campaigns in 2021, motivating thousands of team members to take sustainability actions at home, work, and in their community.

The iHeartEarth public engagement campaign, now in its second year, garnered more than 450 million impressions in 2021, with an estimated media value of \$4.6 million.

K–12 Education

NEEF's K-12 environmental education team expanded on-the-ground Greening STEM efforts with the support of our federal partners. Our second Climate Superstars Challenge and final National Environmental Education Week (EE Week) events complemented that work by engaging middle school students virtually.

Despite changing COVID regulations, NEEF provided approximately \$210,000 in funding to support in-school and after-school programs.

In partnership with USDA Forest Service, Hui o Ho`ohonua, Pearl City High School, and the Ko`olau Mountain Watershed Partnership, a natural resources high school class studied their watershed and helped reinvigorate a native plant nursery on campus.

Other highlights

NEEF, Samsung, and EPA's ENERGY STAR® program presented Climate Superstars, a month-long online environmental challenge designed to engage middle school classrooms in environmental education.

Over 200 educators were registered and survey results showed that 100% of the responding teachers felt confident using the environment as a context for STEM learning after participating, compared to 70% before.

NEEF held its final EE Week in April 2021 and featured educational webinars and downloadable resources.

NEEF also awarded seven grants through the National Park Service-21st Century Community Learning Centers funding




